Application Procedures

1. Collection of Application Forms (No quota)

Application forms can be obtained from school in person or download from school website: (<u>https://bit.ly/3t8ErAn</u>)

2. Return of Application Forms (No set quota)

- **i. Return Method:** Please submit the completed Application Form in person / by post together with the following documents required:
 - ✓ a copy of the child's birth certificate
 - ✓ 4 self-addressed stamped envelopes
 - ✓ a recent photos of the applicant
 - ✓ Application Fee HK\$40 or a crossed cheque for Application Fee made payable to "Caritas Nursery School- Yau Tong" when you return the Application Form. (Please write the name of the applicant on the back of the cheque.) The application fee in non-returnable whether the application is successful or not.

ii. Return Period:

- ✓ Submit in Person : Monday to Friday 10:00 a.m. to 12:00 noon and 2:00 p.m. to 4:00 p.m. , Saturday 9:00 a.m. to 12:00 noon.
- \checkmark Submit by Post : Please mark "Application for Admission" on the envelope .
- For K1 class: Application Form and required documents should be submitted on or before 31st October 2021. Fax or e-mail application will not be accepted.
 For N1 class: Application Form and required documents should be submitted on or before 31st November 2021. Fax or e-mail application will not be accepted.

Interview Arrangement

- 1. The Nursery School will arrange interview for all applicants.
- For K1 class: Interviews will be conducted on November 2021. The interview schedule will be sent to all eligible applicants by post in October 2021.
 For N1 class: Interviews will be conducted on December 2021. The interview schedule will be
- sent to all eligible applicants by post in November 2021.Individual interviews will be arranged. We will observe the child's behavior and interview with the parents.
- 4. Parents are required to accompany their child for the interview.
- 5. Interview will be conducted in Cantonese. Please contact us at <u>2717 1098</u> if interpretation / translation service if required.

Admission Criteria and Factors for Consideration

1. For K1 class: the child should be at least 2 years and 8 months old when she/he is admitted in September 2022.

For N1 class: the child should be at least 2 years old when she/ he is admitted in September 2022.

- 2. The alignment of the parents' view with our school mission and values.
- 3. Interview performance of the child.
- 4. The applicant from families in needs for whole day / long whole day Edu-care service will be given due priority consideration.
- 5. The applicant with sibling(s) currently studying in our school will be given due priority consideration.
- 6. The applicant has sibling(s) of our school's graduated alumni.
- 7. Residents in Yau Tong / Lam Tin / Kwun Tong district.

As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place. Our school has the final interpretation and decision on the factors concerned.

Announcement of Admission Results

We will inform parents of the Admission Results within 2 weeks after the interviews by post.

Registration Arrangements

- Successful applicants of K1: Parents should complete the registration procedures for their child from 6 to 8 January 2022 ("Centralized Registration Dates") by submitting the original of the "Registration Certificate (RC)" to our school and paying the registration fee.
- 2. The registration fee for 2022/23 is HK\$1,405(K1 Class) to HK\$1,570(N1 Class). For those admitted children, the registration fee will be deducted from the school fee in September 2022.
- 3. If parents cannot submit the "Registration Certificate (RC)" during registration, our school may not be able to complete registration for the child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period (September to November 2021).
- 4. Should parents decide to change school after registration, please notify to us in writing. We will return the "Registration Certificate (RC)" but the registration fee will not be refunded. Upon obtaining the "Registration Certificate (RC)", our school will no longer keep the school place for the child.
- 5. Applicants on waiting list will be notified if there were availability after the Centralized Registration Dates.
